APPROVING RESOLUTION NO. 2020-69 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "TO ADOPT THE DETAILS OF THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 5 CY 2020, AS EMBODIED IN THE MDC RESOLUTION NUMBER 7, SERIES OF 2020 OF THE MUNICIPAL DEVELOPMENT COUNCIL OF BOLINAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Resolution No. 2020-69 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Bolinao, Pangasinan had identified items in their Supplemental Investment Program No. 5 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on November 4, 2020 by the Municipal Development Council through MDC Resolution No. 07, S-2020;

WHEREAS, the Supplemental Investment Program No. 5 of the municipality covers the implementation of disaster response projects of the municipality supported by the MDRRM Council thru MDRRMC Resolution No. 4, Series of 2020 dated October 20, 2020;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P4,300,000.00. Funding for the implementation of the same is embodied in their proposed Supplemental Budget No. 5, CY 2020, which was enacted by their Sangguniang Bayan on November 19, 2020 through Appropriation Ordinance No. 2020-05;
