PROVINCIAL RESOLUTION NO. 721-2021

REITERATING TO THE NATIONAL GOVERNMENT THROUGH THE DEPARTMENT OF TRANSPORTATION (DOTr) FOR THE SUSPENSION OF THE IMPLEMENTATION OF THE OPERATIONS OF PRIVATE MOTOR VEHICLES INSPECTION CENTERS (PMVICs)

WHEREAS, the Sangguniang Panlalawigan through Provincial Resolution No. 258-2021, dated February 15, 2021, urged the National Government through the Department of Transportation (DOTr) for the suspension of the implementation of Motor Vehicles Inspection System (MVIS);

WHEREAS, President Rodrigo R. Duterte has ordered then not to make mandatory the implementation of the operations of Private Motor Vehicle Inspection Centers after some groups and government officials all over the country have called for the suspension of the program;

WHEREAS, Department of Transportation (DOTr) Memorandum Circular No. MC-SC-2021-02, dated July 5, 2021, provides for the implementation of a Geographical Area of Responsibility (GAOR) for Renewal of Registration for Light Vehicles and Motorcycles;

WHEREAS, with the new memo, Private Motor Vehicle Inspection Centers (PMVICs) are back and vehicle testing procedures on light vehicles and motorcycles are mandatory in areas where PMVIC are already operational;

WHEREAS, the mandatory implementation of the PMVICs is again untimely considering the serious threat of COVID-19 Delta variant especially for those private motorists who would troop to have their vehicles tested and registered;




