RESOLUTION NO. 723-2017

DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2017 OF THE CITY OF URDANETA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P25,662,063.00 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2017 involving total appropriations of **P25,662,063.00** which was approved on September 26, 2017 through Appropriation Ordinance No. 7, S-2017;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The appropriations for Other Maintenance and Operating Expense shall cover only expenses which are not classified in any of the specific maintenance and other operating expense accounts, in accordance with the Revised Chart of Accounts for Local Government Units under COA Circular No. 2015-009; *and*

2. The projects funded under the 20% of the Annual IRA for development projects (20% development fund) shall be subject to the provisions of DILG and DBM Joint Memorandum Circular (JMC) No. 2017-1, dated February 22, 2017 re "Updated Guidelines on the Appropriation and Utilization of 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects" and DILG Memorandum Circular No. 2010-138 dated December 2, 2010, entitled "Use of the 20% Component of the Annual Internal Revenue Allotment Shares".


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the above-findings shall be complied with by the municipality;

NOW, THEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Clemente B. Arboleda, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia and Jeanne Jinky C. Zaplan, duly seconded, it was –


RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Supplemental Budget No. 2 for Calendar Year 2017 of Urdaneta City, Pangasinan** as of the date fixed therein for its effectivity; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the City Government of Urdaneta;

RESOLVED, FINALLY, that a copy of this resolution be furnished the City Budget Officer of Urdaneta, Pangasinan, for his/her information and guidance.
