RESOLUTION NO. 723-2020

APPROVING RESOLUTION NO. 2020-095 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) CY 2020 AMOUNTING TO FOUR HUNDRED SIXTEEN MILLION PESOS (P416,000,000.00)”

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2020-095 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Sual, Pangasinan endorsed to the Sangguniang Bayan for approval the Revised Annual Investment Program for CY 2020 on May 26, 2020 thru MDC Resolution No. 09, S-2020. This was favorably acted upon by the Sangguniang Bayan on June 10, 2020 thru SB Resolution No. 2020-095;

WHEREAS, the 2020 AIP of the Municipality of Sual was revised to integrate the Supplemental Local Disaster Risk Reduction and Management Fund Investment Plan (LDRRMFIP) which was prepared and endorsed by the MDRRMC thru MDRRMC Resolution No. 2020-001, Series of 2020. The LDRRMFIP includes project in response to the crisis due to COVID-19 pandemic, which was proposed to be funded by the municipality's unexpended balances of their LDRRMF Trust Fund in CYs 2016, 2017, 2018 and 2019 in the amount of P10,000,000.00. This is in accordance with Section 2.5.5 of LBC No. 124, dated March 26, 2020, which states that LGUs are authorized to utilize the LDRRMF beyond the 30% QRF, to address the disaster response requirements of the COVID-19 emergency, among the other purposes sanctioned by the law (i.e. disaster prevention and mitigation, preparedness and rehabilitation and recovery), provided that the same is consistent with the approved LDRRMF as incorporated in the AIP;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
