**PROVINCIAL RESOLUTION NO. 724-2017**

**WHEREAS**, the Municipal Development Council of the Local Government Unit of Laoac, Pangasinan in its Resolution No. 2017-03 has endorsed to the Provincial Development Council the proposed project of the Green Atom Renewable Energy Corporation to undertake the solid waste disposal of the municipality;


