APPROVING RESOLUTION NO. 2020-092 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 5, C.Y. 2020 OF SUAL, PANGASINAN AMOUNTING TO EIGHT MILLION PESOS (P8,000,000.00)”

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2020-092 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sual, Pangasinan had identified items in their Supplemental Investment Program for CY 2020. This was endorsed to the Sangguniang Bayan for approval on June 8, 2020 thru MDC Resolution No. 11, S-2020 and was favorably acted upon by the Sangguniang Bayan on June 10, 2020 thru SB Resolution No. 2020-092;

WHEREAS, the said Supplemental Investment Program of the municipality with a total investment requirement of P8,000,000.00 covers programs and projects to address the crisis brought about by the COVID-19 pandemic and to be funded from the realignment of Continuing Appropriations – LDRRMF 2017 (Capital Outlay);

WHEREAS, funding support for the implementation of the same is embodied in their proposed Supplemental Investment Program No. 05, CY 2020, which was enacted by their Sangguniang Bayan on June 10, 2020 thru Appropriation Ordinance No. 06;


