#### **PROVINCIAL RESOLUTION NO. 726-2019**

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN AND AMONG CIVIL SOCIETY ORGANIZATIONS (CSOs), NAMELY: CARITAS LINGAYEN-DAGUPAN, INC., **PANGASINAN YOUTH** ASSOCIATION, PANGASINAN FEDERATION OF SOLO PARENTS ASSOCIATION, PANGASINAN FEDERATION, DELTACOM PHILIPPINES, **PANGASINAN MEDICAL** SOCIETY, WORLD DEVELOPMENT FOUNDATION, INC. AND ROMAN CATHOLIC **OF** ALAMINOS, INC., AS **PARTNERS** COOPERATION AND RESOURCE SHARING DURING DISASTER SITUATIONS IN THE PROVINCE OF PANGASINAN

WHEREAS, RA No. 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010 under Section 2 (d) mandates local government units to adopt a disaster risk reduction and management approach that is holistic, comprehensive, integrated and proactive in lessening the socio-economic and environmental impacts of disasters including climate change, and promote the involvement and participation of all sectors and stakeholders concerned, at all levels, especially the local community;

**WHEREAS,** under Section 12 (13) of the same law decrees local government units to develop, strengthen and operationalize mechanisms for partnership or networking with the private sectors, Civil Society Organizations (CSOs) and volunteer groups;

**WHEREAS,** DILG Memorandum Circular No. 2018-89 dated June 11, 2018, (Guidelines on Engagements with CSOs) states that only government-accredited CSOs are deemed eligible to participate in the implementation of government programs and get involved in the local disaster preparedness;

WHEREAS, the Province of Pangasinan, through its Provincial Disaster Risk Reduction and Management Office, has expressed its desire to enter into a Memorandum of Agreement Caritas Lingayen-Dagupan, Inc., Pangasinan Youth Association, Pangasinan Federation of Solo Parents Association, Deltacom Philippines, Pangasinan Federation, Pangasinan Medical Society, World Vision Development Foundation, Inc. and Roman Catholic Bishop of Alaminos, Inc., in compliance with the mandate of RA 10121;

**WHEREAS**, the abovementioned stakeholders have also expressed their desire to enter into this Memorandum of Agreement;

**WHEREAS**, relevant to the aforecited mandates of the law and to the expressions of desire, the Memorandum of Agreement shall be entered into and signed between and among the Province of Pangasinan, represented by Honorable Governor Amado I. Espino III and the representatives from each stakeholders;

WHEREFORE, in view of the foregoing, on motion of SP Members Sheila Marie S. Perez-Galicia, Liberato Z. Villegas and Noel C. Bince, duly seconded, it was –

**RESOLVED,** by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Amado I. Espino III, to enter into and sign a Memorandum of Agreement between and among Civil Society Organizations (CSOs), namely: Caritas Lingayen-Dagupan, Inc., Pangasinan Youth Association, Pangasinan Federation of Solo Parents Association, Deltacom Philippines, Pangasinan Federation, Pangasinan Medical Society, World Vision Development Foundation, Inc. and Roman Catholic Bishop of Alaminos, Inc., as partners for cooperation and resource sharing during disaster situations in the Province of Pangasinan;
