**APPROVING RESOLUTION NO. 46, S-2020 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF CALASIAO FOR THE YEAR 2020"**

**WHEREAS**, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 46, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Calasiao, Pangasinan has prepared the municipality's Supplemental Annual Investment Program (AIP) No. 5, CY 2020. This was endorsed by the Council, through MDC Resolution No. 07, S-2020 dated May 27, 2020 to the Sangguniang Bayan for approval;

**WHEREAS**, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 46, S-2020 dated June 1, 2020;

**WHEREAS**, said Supplemental Annual Investment Program, which has a total investment requirement of P11,835,737.00 covers augmentation funds for Personal Services and MOOE of the LGU, additional GAD projects, COVID-19 related PPAs, and other development projects of the LGU;

**WHEREAS**, the new/proposed projects from the realigned funds from the 20% Development Fund conforms with DILG and DBM Joint Memo-Circular No. 2017-1 dated February 22, 2017 (Updated Guidelines on the Appropriation and Utilization of the 20% of the IRA for Development Projects) and DILG and DBM Joint Circular No. 01 dated March 27, 2020 (Additional Guidelines on the Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment for Development Projects in view of the Coronavirus Disease 2019 (COVID-19) Situation);

**WHEREAS**, funding for the Supplemental AIP is sourced from the savings and realignment of some funds of the LGU, to include a portion of their 20% Development Fund. This is embodied in their Supplemental Budget No. 05, FY 2020, and approved by their Sangguniang Bayan through Appropriation Ordinance No. 05, S-2020 dated June 1, 2020;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;


