**PROVINCIAL RESOLUTION NO. 728-2021**

**AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, FOR THE PROCUREMENT OF ONE (1) UNIT OF MOTOR VEHICLE FOR USE BY THE PROVINCIAL GOVERNMENT OF PANGASINAN**

**WHEREAS**, the Provincial Government of Pangasinan is in need of a motor vehicle which shall be used for multi-sectoral services of the Province particularly the Provincial Social Welfare Development Office;

**WHEREAS**, the Provincial Government of Pangasinan intends to procure a motor vehicle for the said office with a total cost of P1,329,200.00, as herein specified, to wit:

**WHEREAS**, the procurement of the vehicle is beneficial to the Province as a means of further enhancing the delivery of services to the people of Pangasinan especially to the needy and less privileged Pangasinenses;



**NOW, THEREFORE**, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


