RESOLUTION NO. 73-2022

DECLARING ORDINANCE NO. 2016-05 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING A PARCEL OF LAND OWNED BY DR. ERWIN RABAGO AND ZOSIMA P. AVELINO COVERED UNDER TRANSFER CERTIFICATE OF TITLE NO. 31149 CONTAINING AN AREA OF TWO THOUSAND ONE HUNDRED SEVENTY THREE SQUARE METERS (2,173 SQ.M.) SITUATED AT BRGY. TANGCARANG, THIS CITY, FROM AGRICULTURAL/RESIDENTIAL USE TO SPECIAL USE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2016-05 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Provincial Planning and Development Officer have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Sections 20 (a) (2), (3 (c) (d) (e) and 447 (2) (viii) (x) of R.A. No. 7160;

WHEREAS, however, the Sangguniang Panlungsod shall consider the points raised by the Provincial Legal Officer stated in her opinion dated December 1, 2016 and the Provincial planning and Development Officer stated in her opinion dated December 21, 2016;

Tangarang, this City, from agricultural/residential use to special use” as within the conferred powers of the Sangguniang Panlungsod to enact;
