APPROVING RESOLUTION NO. 20-024(A) OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "APPROVING THE INCLUSION OF PROJECTS TITLED: 1) PROCUREMENT OF RELIEF GOODS AND OTHER SUPPLIES/MATERIALS AMOUNTING TO SIXTEEN MILLION PESOS (P16,000,000.00), AND 2) PROCUREMENT OF MEDICAL SUPPLIES AMOUNTING TO TWO MILLION EIGHT HUNDRED FIFTY THOUSAND PESOS (P2,850,000.00) IN THE REVISED ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2020 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 20-024(A) to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council-Executive Committee of San Carlos City proposed for the inclusion of two (2) projects in the revised Annual Investment Program (AIP) for CY 2020. This was endorsed by the Council, through CDC Resolution No. 01.A-20, S-2020 dated March 18, 2020 to the Sangguniang Panlungsod for approval. The Sangguniang Panlungsod approved said endorsement through Sangguniang Panlungsod Resolution No. 20-024(A) dated March 30, 2020;

WHEREAS, the two (2) projects namely: the procurement of relief goods, and other supplies and materials and procurement of medical supplies, both to combat the spread of COVID-19 virus, will be charged from the Local Disaster Risk Reduction and Management Fund Balances for the Years 2015 and 2016 of the LGU in the amount of P18,500,000.00;

WHEREAS, the preparation of the Revised AIP is in accordance to Items 6.4 and 6.5 of the NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013;

WHEREAS, likewise, the use of Unexpended LDRRM Fund for COVID-19 related projects is based on Item 2.5.6 of Local Budget Circular No. 124 dated March 26, 2020 of the Department of Budget and Management (Policy Guidelines on the Provision of Funds by Local Government Units for Programs, Projects and Activities to Address the Corona Virus Disease 2019 (COVID-19) Situation);


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;


