**APPROVING RESOLUTION NO. 2020-126 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE 2<sup>ND</sup> SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM - CY 2020 OF THE MUNICIPALITY OF SISON, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Sison, Pangasinan submitted its Resolution No. 2020-126 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Sison, Pangasinan has adopted and endorsed the municipality's Supplemental Annual Investment Program No. 2 thru MDC Resolution No. 02-2020, S-2020 dated March 9, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on June 22, 2020 thru Resolution No. 2020-126, S-2020;

**WHEREAS**, the said Supplemental Annual Investment Program with an investment requirement of P40,252,854.16 covers the implementation of the First Tranche Compensation Adjustment for municipal officials and employees, provision of special risk allowance, fund augmentation for Maintenance and Other Operating Expenses of some officers and disaster risk reduction management program and implementation of new development projects of the municipality;

**WHEREAS**, the Sangguniang Bayan on June 22, 2020 enacted Supplemental Budget No. 2 thru Appropriation Ordinance No. 02-2020, S-2020 to support the implementation of the Supplemental Annual Investment Program No. 2 of the municipality;
