RESOLUTION NO. 735-2021

DECLARING SB RESOLUTION NO. 12, S-2021 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 01 CY 2021 AMOUNTING TO THIRTY THREE MILLION PESOS ONLY (P33,000,000.00) OF THE MUNICIPALITY OF BANI, PANGASINAN FUNDED BY THE GENERAL FUND" AS NOT WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 12, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Local Development Council of Bani, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on January 18, 2021 by the MDC thru Resolution No. 2021-01;

WHEREAS, Supplemental AIP No. 1 of the municipality covers the implementation of various infrastructure and COVID 19 response related projects;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P33,000,000.00. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 01 for CY 2021, which was enacted by the Sangguniang Bayan thru Appropriation Ordinance No. 01, S-2021 on March 16, 2021;

WHEREAS, however, the Annual Investment Program CY 2021 was disapproved by the Sangguniang Panlalawigan thru SP Resolution No. 391-2021. Likewise, the Annual Budget CY 2021, which will enable the full implementation of the AIP, was declared inoperative in its entirety by the Sangguniang Panlalawigan thru SP Resolution No. 392-2021.

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –


