PROVINCIAL RESOLUTION NO. 736-2020

AUTHORIZING THE PROVINCIAL GOVERNOR TO PURCHASE A LOT COVERED BY ORIGINAL CERTIFICATE OF TITLE NO. 16858 IN THE NAME OF AURELIO C. REYES, WITH AN AREA OF 20,993 SQUARE METERS LOCATED AT BARANGAY MAGALONG, MABINI, PANGASINAN INTENDED FOR THE SATELLITE MULTIPURPOSE BUILDING OF THE PROVINCE

WHEREAS, the Provincial Government of Pangasinan intends to put a Satellite Multi-Purpose Building in the western part of the Province to be located at Barangay Magalong, Mabini, Pangasinan;

WHEREAS, the Provincial Appraisal Committee has conducted an ocular inspection/survey and appraisal/assessment over the subject lot located at Barangay Magalong, Mabini, Pangasinan and has recommended that the Provincial Government of Pangasinan can acquire the said property at P200.00 per square meter;

WHEREAS, the Satellite Multi-Purpose Building can serve as an additional facility of Pangasinan for the conduct of official gatherings such as meetings, seminars, conferences and other related services and activities of the Province;

WHEREAS, one of the corporate powers of every local government unit is to acquire and convey real or personal property, as embodied in Section 22 (a) (4) of the same Code;

WHEREAS, the authority of the Governor to purchase the subject lot is in accord with his power to initiate and maximize the generation of resources and revenues, and apply the same to the implementation of development plans, program objectives and priorities, particularly those resources and revenues programmed for agro-industrial development and countrywide growth and progress, as embodied in Section 465 (3) of the same Code;
