RESOLUTION NO. 738-2020

DECLARING ORDINANCE NO. 2020-16 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE LIFTING THE TEMPORARY CLOSURE OF THE FOLLOWING TOURIST SPOTS IN THE CITY OF ALAMINOS, PANGASINAN STARTING JULY 1, 2020, TO WIT: HUNDRED ISLANDS NATIONAL PARK, LUCAP PARK. E-KAWAYAN FACTORY; BUED MANGROVE PARK AND BOLO BEACH" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2020-16 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 21 (a) and Section 458 (a) (1) (iv) and (xii) of RA 7160 and Article 43 of its Implementing Rules and Regulations;

WHEREAS, subject ordinance shall take effect after the Sanggunian has complied with the posting requirement pursuant to Section 59 (a) of RA 7160;


