APPROVING RESOLUTION NO. 2020-229 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 4 FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2020-229 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Balungao, Pangasinan has identified programs/projects/activities to address emergency response measures to COVID-19 pandemic. This is embodied in the municipality's Supplemental Investment Program No. 4 which was endorsed thru MDC Resolution No. 2020-04 dated April 10, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan thru Resolution No. 2020-229 dated April 15, 2020. This is in pursuance to Sections 106,109, 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 4 has an investment requirement amounting to P8,991,234.00 which will be funded from Bayanihan Grant to Cities and Municipalities (BGCM) under RA No. 11469 (The Bayanihan to Heal As One Act);


