RESOLUTION NO. 742-2020

DECLARING MUNICIPAL ORDINANCE NO. 95, S-2020 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AN ORDINANCE ADOPTING THE OFFICIAL SEAL OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, REGULATING ITS USE AND PROVIDING PENALTY FOR VIOLATIONS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Ordinance No. 95, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 22 (a) (3), (b) of RA 7160; and Section 2, Chapter IV and Sections 44 and 45 of Republic Act No. 8491, also known as "An Act Prescribing the Code of the National Flag, Anthem, Motto, Coat-of-Arms and Other Heraldic Items and Devices of the Philippines; and Sections 5, 49, 50 and 51 of the Implementing Rules and Regulations of RA 8491;

WHEREAS, subject ordinance shall take effect after the Sanggunian has complied with the posting and public requirements pursuant to Sections 59 (c) and 511 (a) of RA 7160;


WHEREAS, the new Seal or Logo of the local government unit must be filed with the National Historical Institute and Registered with the Department of the Interior and Local Government;
