APPROVING RESOLUTION NO. 125, S-2020 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN FOR CALENDAR YEAR 2020 OF SUPPLEMENTAL BUDGET NO. 2 OF THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Resolution No. 125, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of San Nicolas, Pangasinan has formulated, adopted and endorsed the municipality's Supplemental Investment Program No. 2 thru MDC Resolution No. 02, CY 2020 dated April 20, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan thru Resolution No. 125, S-2020 dated April 24, 2020. This is in pursuance to Sections 106, 109, 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 2 has an investment requirement amounting to P11,782,830.00 covers programs, projects and activities to address emergency response measures to COVID-19 pandemic. This will be funded from Bayanihan Grant to Cities and Municipalities (BGCM) under RA No. 11469 (The Bayanihan to Heal As One Act);


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
