**RESOLUTION NO. 744-2020**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR  
CALENDAR YEAR 2020 OF SAN NICOLAS, PANGASINAN  
INVOLVING A TOTAL APPROPRIATION OF P11,782,830.00  
OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2020 involving total appropriations of **P11,782,830.00** which was approved on April 24, 2020 through Appropriation Ordinance No. 2, S-2020;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the finding that the appropriation and utilization of the Bayanihan Grant to Cities and Municipalities shall be in accordance with the Local Budget Circular No. 125 dated April 7, 2020;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the finding shall be complied with by the municipality and shall notify the offices concerned of the actions taken thereon;
