APPROVING SB RESOLUTION NO. 27, S-2021 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED “APPROVING THE 1ST SUPPLEMENTAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2021 OF THE MUNICIPALITY OF MANAOAG, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its SB Resolution No. 27, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution and found out that the Municipal Development Council of Manaoag, Pangasinan prepared the municipality’s 1st Supplemental Investment Program for CY 2021. This was endorsed by the Council through MDC Resolution No. 01, Series of 2021, Series of 2021, dated May 12, 2021 to the Sangguniang Bayan for approval;

WHEREAS, the said Supplemental AIP has a total investment requirement of P39,356,477.00;

WHEREAS, funding for the Supplemental AIP is embodied in LGU’s Supplemental Budget No. 1, FY 2021 in the amount of P39,256,477.00, which was approved by the Sangguniang Bayan through Appropriation Ordinance No. 01, Series of 2021. The remaining amount of P100,000.00 is charged to *LGSF-DRRA Trust Fund* (LBM 134-2020);
