APPROVING RESOLUTION NO. 55-2018 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "APPROVING THE REVISED SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR CALENDAR YEAR 2018 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Resolution No. 55-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, has conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of the of the Local Government Code of 1991. The Local Development Council of Urbiztondo, Pangasinan had identified items in their Revised Supplemental Investment Program No. 1 for CY 2018. This was endorsed to the Sangguniang Bayan for approval on December 12, 2018 thru MDC Executive Committee Resolution No. 01, S-2018 and was approved by the Sangguniang Bayan on December 14, 2018 thru SB Resolution No. 55, S-2018;
