WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Resolution No. 55-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

The Local Development Council of Urbiztondo, Pangasinan had identified items in their Revised Supplemental Investment Program No. 1 for CY 2018. This was endorsed to the Sangguniang Bayan for approval on December 12, 2018 thru MDC Executive Committee Resolution No. 01, S-2018 and was approved by the Sangguniang Bayan on December 14, 2018 thru SB Resolution No. 55, S-2018;
