RESOLUTION NO. 75-2020

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2019 OF BALUNGAO, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P2,616,932.50 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2019 involving total appropriations of **P2,616,932.50** which was approved on November 27, 2019 through Appropriation Ordinance No. 2019-03 and approved by the Municipal Mayor on December 5, 2019;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993; *and*

2. The appropriation for Other Maintenance and Operating Expenses shall cover only other expenses not otherwise classified under any of the specific maintenance and other operating expense accounts, in accordance with the Revised Chart of Accounts for LGUs under COA Circular No. 2015-009 dated December 1, 2015.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

NOW, THEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was


RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Supplemental Budget No. 3 for Calendar Year 2019 of Balungao, Pangasinan** as of the date fixed therein for its effectivity; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Balungao;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Balungao, Pangasinan, for its information and guidance.
