DECLARING ORDINANCE NO. 2021-35 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE CHANGING THE POSITION TITLES OF THE POSITIONS OF ADMINISTRATIVE OFFICER V (CASHIER III), SG-18/1 TO SENIOR ADMINISTRATIVE ASSISTANT V, SG-18/1 UNDER THE TREASURER'S OFFICE AND ADMINISTRATIVE AIDE III (CLERK I) SG-3/1 TO ADMINISTRATIVE AIDE III (DRIVER I) UNDER THE CITY ASSESSOR'S OFFICE AND UPGRADING THE POSITION OF ADMINISTRATIVE ASSISTANT VI (COMPUTER OPERATOR III), SG-12/1 TO ADMINISTRATIVE OFFICER V, SG-18/1 UNDER THE CITY HUMAN RESOURCE AND MANAGEMENT OFFICE OF THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT


