**APPROVING RESOLUTION NO. 2021-494 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “APPROVING THE RE-PROGRAMMING OF THE 20% MUNICIPAL DEVELOPMENT FUND OF THE MUNICIPALITY FOR FY 2021”**

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its SB Resolution No. 2021-494 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution;

**WHEREAS**, the Local Development Council of Balungao, Pangasinan through MDC Resolution No. 2021-05 dated June 17, 2021 has endorsed to the Sangguniang Bayan for approval the reprogramming of the 20% development fund amounting to P4,000,000.00 which was allocated for the Rehabilitation of Hanging Bridges to the improvement of the Municipal Park and Rehabilitation of the Commonwealth and Rizal Monuments-Phase II;

**WHEREAS**, the Sangguniang Bayan through Resolution No. 2021-494 dated July 14, 2021 approved the said reprogramming;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Balungao, Pangasinan;




