RESOLUTION NO. 758-2020

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2020 OF BASISTA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P5,616,945.85 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2020 involving total appropriations of **P5,616,945.85** which was approved on June 30, 2020 through Appropriation Ordinance No. 03, S-2020;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The implementation of the First Tranche Salary Adjustment to all Municipal Officials and Employees shall be accordance with the provisions of Local Budget Circular No. 121 dated January 24, 2020 Re: *Implementation of the First Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to the Republic Act No. 11466;*
2. The grant of Hazard Pay to government personnel who physically reported for work during the period of implementation of the Enhanced Community Quarantine relative to the COVID-19 Outbreak shall be in accordance with the provisions of Administrative Order No. 26 by the President of the Philippines dated March 23, 2020 and Budget Circular No. 2020-1 dated March 24, 2020;

3. The disbursement of appropriation for Performance-Based Bonus of Officials and Employees shall be subject to the provisions of DILG-DBM Joint Memorandum Circular No. 2019-01 dated November 21, 2019.
4. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
5. The salary grade allocation of new Administrative Officer position under the Office of the Mayor should be changed to conform with the provisions of CSC Memorandum Circular No. 10;
6. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2020 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007;
7. The position titles of the following items under the Office of the Municipal Accountant conform with the provisions of Budget Circular No. 2004-3 dated March 6, 2002 entitled "Conversion of Positions Performing Staff/Non-Technical Functions":

8. The salary of Valentino Aquino, Administrative Aide IV under the Office of the Mayor should be adjusted from P124,020.00 to P124,260.00 per annum.


