RESOLUTION NO. 76-2018

DECLARING MUNICIPAL ORDINANCE NO. 3-2017 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING DEATH-AID OF ONE THOUSAND FIVE HUNDRED PESOS (P1,500.00) TO THE BENEFICIARIES OF EVERY REGISTERED PERSON WITH DISABILITY (PWDs) OF THE MUNICIPALITY OF ANDA, PANGASINAN WHO WILL DIE AT ANY CAUSE OR AT ANY GIVEN SITUATION" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Ordinance No. 3-2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 17 (b) (2) (ii) of RA 7160; Section 4 of the Implementing Rules and Regulations of RA No. 10754 (An Act Expanding the Benefits and Privileges of Persons with Disability); Section 40 (a) of RA No. 10070 (Establishing Institutional Mechanism to Ensure the Implementation of Programs and Services for Persons with Disabilities in Every Province, City or Municipality, Amending RA No. 7277, otherwise known as the Magna Carta for Disabled Persons, as amended, and For Other Purposes); and the Convention on the Rights of Persons with Disabilities;
