RESOLUTION NO. 76-2020

APPROVING RESOLUTION NO. 38-2019 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR CY 2019 OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Resolution No. 38-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of San Jacinto, Pangasinan has prepared the municipality’s Supplemental Investment Program No. 1 for CY 2019. This was endorsed by the Council thru MDC Resolution No. 2019-1 dated September 23, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 38-2019 dated October 2, 2019;

WHEREAS, the Supplemental Investment Program of said municipality has a total investment requirement of P116,817,912.40. Of this, the sum of P33,397,785.40 will be financed by the LGU as augmentation funds for Personal Services, MOOE, Capital Outlay of various offices/departments, and for the implementation of development projects of the LGU. This is embodied in the municipality’s Supplemental Budget No. 1, CY 2019 and approved and enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2019-02 dated October 2, 2019;

WHEREAS, the remaining balance will be sourced from the Trust Fund (P500,00.00), Tobacco Excise Tax Share (P16,784,127.00), 2018 Local Government Support Fund – Financial Assistance to LGUs (P6,236,000.00) and outsources (P59,900,000.00);

WHEREAS, projects identified for funding from the share of the LGU Tobacco Excise Tax and 2018 LGSF-FA are based on RA 8240, as amended by RA 10351, and Local Budget Circular No. 117, dated February 5, 2018 of the Department of Budget and Management (Guidelines on the Release and Utilization of the Local Government Support Fund-Other Financial Assistance to Local Government Units in the FY 2018 General Appropriations Act, RA 10964), respectively;


WHEREAS, for the projects to be funded by the 20% Development Fund, particularly the “Construction of Bureau of Fire Protection (BFP) Building” and the “Purchase of Lot for the BFP Project”, it is respectfully suggested that an agreement, e.g. MOA, be made between the LGU and the BFP as to the use, ownership, roles, responsibilities, obligations and other pertinent provisions, terms, clauses, and conditions on the land and building;

WHEREFORE, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 38-2019 of the Sangguniang Bayan of **San Jacinto**, Pangasinan, entitled “Approving the Supplemental Investment Program No. 1 for CY 2019 of the Municipality of San Jacinto, Pangasinan”;
