**RESOLUTION NO. 762-2021**

**APPROVING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2021 OF THE CITY OF ALAMINOS, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P27,187,092.31, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2021 involving total appropriations of P27,187,092.31, which was enacted on July 26, 2021 through Appropriation Ordinance No. 2021-03;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The funding sources for the subject Supplemental Budget were determined in accordance with the provisions of Section 321 of R.A. No. 7160 and Article 417(a) of its Implementing Rules and Regulations (IRR) as amended by Administrative Order No. 47 dated April 12, 1993;

All programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2021 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 series of 2007 dated 08 March 2007 and DILG-DBM Joint Memorandum Circular No. 01 dated 27 March 2020;
3. All procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations; and
4. The grant of Gratuity Pay to Job Order Workers in the Government Service shall be in accordance to Administrative Order No. 20, dated January 10, 2020.


**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the city;
