**RESOLUTION NO. 767-2020**

**APPROVING RESOLUTION NO. 154-S-2020 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 3 FOR CY-2020 OF THE LOCAL GOVERNMENT OF SAN FABIAN, PANGASINAN AMOUNTING TO NINE MILLION SIX HUNDRED FORTY-FOUR THOUSAND TWO HUNDRED TWENTY-FIVE PESOS AND FIFTY-NINE CENTAVOS (P9,644,225.59)"**

**WHEREAS**, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 154-S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of San Fabian, Pangasinan prepared their Supplemental Annual Investment Program (AIP) No. 3 for CY 2020. This was endorsed by the Council, through MDC Resolution No. 03, S-2020 dated April 28, 2020 to the Sangguniang Bayan for approval;

**WHEREAS**, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 154-S-2020 dated July 1, 2020;

**WHEREAS**, said Supplemental Annual Investment Program, which has a total investment requirement of P9,644,225.59 is intended to finance Hazard Pay/Special Risk Allowance to frontliners/public health workers, COVID-19 related PPAs and other development projects of the LGU;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
