APPROVING RESOLUTION NO. 2021-145 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED, "STRONGLY APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 4, CY 2021 FOR THE ACQUISITION OF AMBULANCE (2 UNITS) AND ACQUISITION OF DUMP TRUCKS (3 UNITS) TO BE FUNDED UNDER THE FY 2021 LOCAL GOVERNMENT SUPPORT FUND- OTHER FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-OTHER FA TO LGUs)"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its SB Resolution No. 2021-145 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

WHEREAS, the Municipal Development Council-Executive Committee of Mangaldan, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 4 for CY 2021. This was endorsed by the Council to the Sangguniang Bayan for approval through MDC Executive Committee Resolution No. 2, Series of 2021 dated May 27, 2021;

WHEREAS, said Supplemental AIP which has a total investment requirement of P10,000,000.00 covers the acquisition of two (2) units of Ambulance and three (3) units of Dump Truck by the LGU;

WHEREAS, funding for the Supplemental AIP will be sourced from the FY 2021 Local Government Support Fund-other Financial Assistance to Local Government Units as per Local Budget Circular No. 131 of the Department of Budget and Management;


