APPROVING MUNICIPAL RESOLUTION NO. 162, S-2020 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN FOR CALENDAR YEAR 2020 FOR SUPPLEMENTAL BUDGET NO. 3 OF THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Resolution No. 162, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of San Nicolas, Pangasinan has formulated, adopted and endorsed the municipality's Supplemental Investment Program No. 3 thru MDC Executive Committee Resolution No. 03, CY 2020 dated June 2, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan thru Resolution No. 162, S-2020 dated June 15, 2020. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 03 with an investment requirement amounting to P273,668.00 covers the provision of hazard pay benefits of all employees who rendered skeletal workforce from May 1-15, 2020;

WHEREAS, on June 15, 2020, the Sangguniang Bayan enacted Supplemental Budget No. 3 through thru Appropriation Ordinance No. 3, S-2020 to support the implementation of the Supplemental Investment Program No. 3 of the municipality;
