**APPROVING RESOLUTION NO. 220, S-2021 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 5 WITH THE CY 2021 SUPPLEMENTAL ANNUAL INVESTMENT PLAN NUMBER 4 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Asingan, Pangasinan submitted its SB Resolution No. 2020, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

**WHEREAS**, the Local Development Council of Asingan, Pangasinan has identified items in their Supplemental Annual Investment Plan No. 4 for CY 2021. This was endorsed to the Sangguniang Bayan on August 05, 2021 through MDC Resolution No. 5, S-2021;

**WHEREAS**, the Supplemental Investment Plan of the municipality covers the reprogramming/realignment of some programs of previous years to augment funding for COVID-19 related programs/projects/activities;

**WHEREAS**, the new programs/projects/activities to be funded by the 20% development fund conform to Section 2.1 of the DILG & DBM JMC No. 01 dated March 27, 2020 (*Additional Guidelines on the Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects in view of the Corona Virus Disease 2019 Situation*);

**WHEREAS**, funding support for the proposed Supplemental Investment Program, which has a total investment requirement of Php1,500,000.00 is embodied in the municipality's Supplemental Budget No. 04, CY 2021, which was approved and enacted by their Sangguniang Bayan on August 16, 2021 through Appropriation Ordinance No. 4, series of 2021.




