PROVINCIAL RESOLUTION NO. 773-2020

URGING THE PNP PANGASINAN POLICE PROVINCIAL OFFICE TO FLAG DOWN TRUCKS AND CLOSED VANS FOR PHYSICAL INSPECTIONS TO AVOID SMUGGLING IN OF LOCALLY STRANDED INDIVIDUALS (LSIs) IN THE PROVINCE OF PANGASINAN

WHEREAS, border control and quarantine checkpoints are being maintained in the Province of Pangasinan during this period of COVID-19 pandemic;

WHEREAS, the Pangasinan Police Provincial Office plays an important role in manning border control and quarantine checkpoints in the Province of Pangasinan;

WHEREAS, since Pangasinan is now under Modified General Community Quarantine, more Locally Stranded Individuals (LSIs) coming from Metro Manila and in other provinces will attempt to enter the Province;

WHEREAS, among guidelines observed in quarantine control points is the unrestricted passage of trucks and closed vans carrying food products, basic and essential commodities;

WHEREAS, to date, the Province of Pangasinan has already recorded Two Hundred Sixty-Two (262) confirmed COVID-19 cases in the Province;

WHEREAS, the Sangguniang Panlalawigan in its aim to prevent further contagion/community transmission in Pangasinan wanted that trucks and closed vans shall undergo thorough inspections so as to avoid the entry of undocumented LSIs in the Province;


