APPROVING RESOLUTION NO. 31, S-2020 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN OF SUPPLEMENTAL BUDGET NO. 4, CY 2020"

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Resolution No. 31, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Aguilar, Pangasinan had identified items in their Supplemental Investment Program No. 4 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on July 9, 2020 by the MDC thru Resolution No. 4, S-2020 and was favorably acted upon by the Sangguniang Bayan on July 20, 2020 thru SB Resolution No. 31, S-2020;

WHEREAS, the Supplemental Investment Program No. 4 of the municipality covers fund augmentation for the Personal Services of municipal offices (Performance-Based Bonus) and implementation of disaster risk reduction programs and infrastructure projects;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P5,751,538.24. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 04, CY 2020, which was enacted by their Sangguniang Bayan on July 20, 2020 thru Appropriation Ordinance No. 04, S-2020;
