PROVINCIAL RESOLUTION NO. 778-2021

URGING THE PROVINCIAL GOVERNMENT OF PANGASINAN THROUGH PROVINCIAL GOVERNOR AMADO I. ESPINO III, THE PROVINCIAL INTER-AGENCY TASK FORCE AND PROVINCIAL HEALTH OFFICE TO FACILITATE EMERGENCY PURCHASES OF MUCH NEEDED MEDICINES, MATERIALS AND EQUIPMENT TO FURTHER AUGMENT HOSPITAL CAPABILITY IN FIGHTING COVID-19 IN THE PROVINCE OF PANGASINAN

WHEREAS, as the number of cases in Pangasinan continues to grow, there have been an increased admission of COVID-19 positive cases in the fourteen provincial government hospitals of the Province;

WHEREAS, the Provincial Government needs to initiate proactive measures to address the surge of COVID-19 by facilitating emergency purchases of much needed medicines, materials and equipment that are crucial to be used for caring of ill patients during the pandemic;

WHEREAS, Remdesivir, Tocilizumab, ventilators, oxygen tanks, high-flow oxygen, PPEs and body bags are among the much needed medicines, materials and equipment that are deemed necessary to be purchased by the Province;

WHEREAS, the Sangguniang Panlalawigan aims to augment the significant resources needed to further enhance the work towards protecting the people from COVID-19;

WHEREAS, it is the shared commitment and responsibility of the executive and legislative branches of the Province of Pangasinan to ensure that all people have access to all the needed resources to prevent, detect, treat and defeat COVID-19;


