RESOLUTION NO. 78-2020

DECLARING ORDINANCE NO. 01-2019 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "AN ORDINANCE IMPOSING UPON PARENTS AND GUARDIANS TO REQUIRE THEIR MINOR CHILDREN OR WARDS TO STAY UNDER THEIR CARE IN THEIR HOMES BETWEEN THE HOURS OF 10:00 P.M. TO 4:00 A.M. (CURFEW PERIOD) OF THE FOLLOWING DAY PRESCRIBING FINES AND PENALTIES THEREFOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Ordinance No. 01-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 17 (b) (2) (iii) and (iv), Section 447 (a) (5) (xiv) of RA 7160; Section 3 (2) Article XV of the Philippine Constitution; Article 1 of Presidential Decree No. 603 (Child and Welfare Code); and Section 2 of RA No. 7610 (Special Protection of Children Against Abuse, Exploitation, and Discrimination Act);

WHEREAS, however, the Sangguniang Bayan shall take into consideration the observations of the Provincial Legal Officer stated in her opinion dated November 25, 2019;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 01-2019 of the Sangguniang Bayan of **San Jacinto**, Pangasinan, entitled “An Ordinance imposing upon parents and guardians to require their minor children or wards to stay under their care in their homes between the hours of 10:00 p.m. to 4:00 a.m. (curfew period) of the following day prescribing fines and penalties therefor” as within the conferred powers of the Sangguniang Bayan to enact;
