#### **RESOLUTION NO. 78-2021**

APPROVING RESOLUTION NO. 59, S-2020 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN OF SUPPLEMENTAL BUDGET NO. 5 CY 2020"

**WHEREAS**, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Resolution No. 59, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991:

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Aguilar, Pangasinan had identified items in their Supplemental Investment Program No. 5 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on December 14, 2020 by the Municipal Development Council through Resolution No. 10, S-2020;

**WHEREAS**, the Supplemental Investment Program No. 5 of the municipality covers fund augmentation for the Personal Services (Collective Negotiation Agreement Incentive to all officials and employees), Maintenance and Other Operating Expenses of some municipal offices, and implementation of disaster risk reduction programs of the municipality;

**WHEREAS**, the proposed Supplemental Investment Program has an investment requirement of P2,587,150.00. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 05, CY 2020, which was enacted by their Sangguniang Bayan on December 18, 2020 through Appropriation Ordinance No. 06, S-2020;
