APPROVING MUNICIPAL RESOLUTION NO. 160-2021 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 02, SERIES OF 2021 OF ANDA, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its SB Resolution No. 160-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Local Development Council of Anda, Pangasinan had identified items in their Supplemental Investment Program No. 02 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on November 17, 2021 through MDC Resolution No. 04, Series of 2021;

WHEREAS, the Supplemental Investment Program No. 2 covers fund augmentation for the Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices and implementation of disaster risk reduction and management program of the LGU;

WHEREAS, funding support for the implementation of the said SIP in the amount of P3,388,055.00 is embodied in the municipality’s Supplemental Budget No. 02 for CY 2021 which was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2021-05 on November 22, 2021 and approved by the Municipal Mayor on December 3, 2021;
