EXTENDING INVITATION TO THE SCHOOLS DIVISIONS SUPERINTENDENTS OF THE PROVINCE OF PANGASINAN TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS SEPTEMBER 20, 2021 REGULAR (PHYSICAL) SESSION TO UPDATE THE BODY ON THE PLANS AND PROGRAMS OF THE DEPARTMENT OF EDUCATION IN LINE WITH THE SCHEDULED SCHOOL OPENING

WHEREAS, the COVID-19 pandemic and the implementation of different kinds of community quarantine in the country have greatly affected the educational system in the School Year 2020-2021;

WHEREAS, there have been changes in the curriculum and structure of education for the School Year 2020-2021;

WHEREAS, DepEd Department Order No. 29-2021, dated August 5, 2021, declared September 13, 2021 as the opening date of classes for School Year 2021-2022;

WHEREAS, the Sangguniang Panlalawigan is desirous again to hear from the Schools Divisions of Pangasinan about their continuity plans for education for the School Year 2021-2022;

WHEREAS, the Department of Education is an active partner of the Provincial Government of Pangasinan in the promotion of its worthwhile plans and programs and it is the intention of the Sangguniang Panlalawigan to support the Learning Continuity Plans of the Schools Divisions in Pangasinan aimed toward ensuring quality education amidst the challenges of COVID-19 pandemic;
