**PROVINCIAL RESOLUTION NO. 783-2021**

**URGING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES-REGIONAL OFFICE TO FURNISH THE SANGGUNIANG PANLALAWIGAN OF PANGASINAN WITH ALL PERTINENT DOCUMENTS AND COMMUNICATIONS RELATIVE TO THE APPLICATION, POSSIBLE ACTION ON THE GRANT OF ENVIRONMENTAL CLEARANCE CERTIFICATE AND/OR PERMIT ON THE ALLEGED LARGE-SCALE MINING PROJECT TO BE CONDUCTED IN THE PROVINCE AND TO SUBMIT THE REPORT ON THE RESULT OF THE PROCEEDINGS**



**NOW, THEREFORE**, on motion of SP Member Noel C. Bince, duly seconded, it was –


