PROVINCIAL RESOLUTION NO. 784-2021

URGING ALL LOCAL CHIEF EXECUTIVES OF LINGAYEN, LABRADOR, SUAL, BINMALEY AND DAGUPAN CITY TO BE STRAIGHTFORWARD, TRANSPARENT AND CIRCUMSPECT IN THEIR ACQUIESCENCE/CONSENT TO THE ALLEGED LARGE-SCALE MINING PROJECT TO BE CONDUCTED IN THE PROVINCE

WHEREAS, a large-scale mining project is to be undertaken in the Province covering the Municipalities of Lingayen, Labrador, Sual and Binmaley, and the City of Dagupan;

WHEREAS, pursuant to Provincial Resolution No. 754-2021, the Sangguniang Panlalawigan conducted an inquiry to confirm the veracity of the alleged implementation of the said project in the Province;

WHEREAS, the Question Hour was held on its September 13, 2021 Regular (Physical) Session and was attended by the representatives of the Department of Environment and Natural Resources, and League of Municipalities Provincial Chapter President who rendered initial reports on the matter;

WHEREAS, one of the legislative measures adopted by the Sangguniang Panlalawigan as a result of the inquiry is to request the Local Chief Executives of the Municipalities of Lingayen, Labrador, Sual and Binmaley, and the City of Dagupan to be straightforward, transparent and circumspect in their consent to the alleged large-scale mining project to be conducted in the Province bearing in mind the environmental soundness of the project and under such conditions and terms that are to the best interest of their constituents;


