RESOLUTION NO. 787-2020

DECLARING MUNICIPAL ORDINANCE NO. 71-2020 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING ANY ACT OF DISCRIMINATION AGAINST **HEALTHWORKERS.** FRONTLINERS, AND OTHER PERSONS ACTUALLY OR SUSPECTED TO BE INFECTED OF OR EXPOSED TO COVID-19 INCLUDING THEIR FAMILIES AND RELATIVES, AND **RETURNING OVERSEAS FILIPINO WORKERS AND PROVIDING** PENALTIES FOR VIOLATION THEREOF OTHERWISE KNOWN AS "NATIVIDAD COVID-19 ANTI-DISCRIMINATION THE **ORDINANCE OF 2020" AS WITHIN THE CONFERRED POWERS OF** THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Natividad, Pangasinan submitted its Municipal Ordinance No. 71-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (5) (xii) of RA 7160 and the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines;

WHEREAS, however, the Sanggunian shall consider the observations of the Provincial Legal Officer stated in her opinion dated August 10, 2020;

WHEREAS, subject ordinance shall take effect after the Sanggunian has complied with the requirements of posting and publication pursuant to Sections 59 (a) and 511 (a) of RA 7160;

> **RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 71-2020 of the Sangguniang Bayan of **Natividad**, Pangasinan, entitled "An Ordinance prohibiting any act of discrimination against healthworkers, frontliners, and other persons actually or suspected to be infected of or exposed to COVID-19 including their families and relatives, and returning Overseas Filipino Workers and providing penalties for violation thereof otherwise known as the "Natividad COVID-19 Anti-Discrimination Ordinance of 2020" as within the conferred powers of the Sangguniang Bayan to enact;
