INVITING ORE. GOLD, AND **VANADIUM** RESOURCES, (PHILIPPINES) INC., **DEPARTMENT** ENVIRONMENT AND NATURAL RESOURCES, LEAGUE OF **MUNICIPALITIES PROVINCIAL CHAPTER** PRESIDENT. ENVIRONMENTAL ADVOCACY GROUP TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS SEPTEMBER 20, 2021 REGULAR (PHYSICAL) SESSION TO BRIEF AND/OR UPDATE THE BODY ON THE IMPLEMENTATION OF AN ALLEGED LARGE-SCALE MINING PROJECT IN THE PROVINCE **OF PANGASINAN**

WHEREAS, the Sangguniang Panlalawigan, during its Question Hour held on September 13, 2021 Regular Session, has invited the Department of Environment and Natural Resources and the League of Municipalities Provincial Chapter President to confirm the veracity of the alleged implementation of a large-scale mining project in the Province of Pangasinan;

WHEREAS, the Sangguniang Panlalawigan has been informed that a large-scale mining project is to be undertaken in the Province covering the Municipalities of Lingayen, Labrador, Sual and Binmaley, and the City of Dagupan;

WHEREAS, the project proponent has been identified as Iron Ore, Gold, and Vanadium Resources, Inc., an Australian mineral exploration company;

WHEREAS, the Sangguniang Panlalawigan deemed it necessary to schedule again a Question Hour and invite the project proponent to brief the Body on the development of the implementation of the project;

WHEREAS, Section 20 of the Internal Rules of Procedure of the 10th Sangguniang Panlalawigan of Pangasinan provides that a Question Hour is the period of time allotted for members of the Sanggunian to ask questions from invited resource persons coming from both the government and private sectors, usually heads of offices, technical men and prominent individuals, primarily intended to seek information from the latter on certain matters that are of public interest and in aid of legislation;

NOW, THEREFORE, on motion of SP Member Von Mark R. Mendoza, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan of Pangasinan in session assembled to invite, as they are hereby invited, the Iron Ore, Gold, And Vanadium Resources, (Philippines) Inc., Department of Environment and Natural Resources, League of Municipalities Provincial Chapter President, environmental advocacy group to a Question Hour of the Sangguniang Panlalawigan during its September 20, 2021 Regular (Physical) Session to brief and/or update the body on the implementation of an alleged large-scale mining project in the Province of Pangasinan;
