**APPROVING RESOLUTION NO. 2020-29 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED "APPROVING ANNUAL SUPPLEMENTAL PROGRAM NO. 2020-1 OF THE SUPPLEMENTAL BUDGET NO. 2020-1 OF THE MUNICIPALITY OF SAN MANUEL, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Resolution No. 2020-29 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of San Manuel, Pangasinan has formulated, adopted and endorsed the municipality's Supplemental Annual Investment Program No. 1 thru MDC Resolution No. 02, S-2020 dated April 7, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on April 11, 2020 thru Resolution No. 2020-29. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the Supplemental Annual Investment Program with an investment requirement amounting to P16,140,092.00 covers programs/projects/activities to address emergency response measures to COVID-19 pandemic and fund augmentation for Personal Services and Capital Outlay of some offices;

**WHEREAS**, the identified programs/projects to be funded from Bayanihan Grant to Cities and Municipalities in the amount of P13,203,351.00 are consistent with Local Budget Circular No. 125 dated April 7, 2020 (Guidelines on the Release and Utilization of the Bayanihan Grant to Cities and Municipalities);


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
