**APPROVING RESOLUTION NO. 2018-245 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF STA. BARBARA, PANGASINAN, CALENDAR YEAR 2018, REQUIRING A TOTAL FUNDING OF THREE MILLION SIX HUNDRED SIXTY NINE THOUSAND EIGHT HUNDRED THIRTY FOUR PESOS (P3,669,834.00)"**

**WHEREAS**, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2018-245 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, has conducted initial review and study on said resolution and found out that the Municipal Development Council of Sta. Barbara, Pangasinan has prepared the municipality's Supplemental Annual Investment Program for CY 2018. This was endorsed by the Council through MDC Resolution No. 2018-08 dated November 23, 2018 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 2018-245 dated December 5, 2018;

**WHEREAS**, said Supplemental Annual Investment Program which has a total investment requirement of P3,669,834.00 covers the Collective Negotiation Agreement (CNA) incentives of qualified LGU officials and employees, salaries and other Personal Services Expenses of the five (5) created positions in the LGU, and some other investment requirements covering Capital Outlays and Maintenance and Other Operating Expenses of the Office of the Mayor, Office of the Sangguniang Bayan and Office of the Municipal Accountant to further improve the delivery of public services;

**WHEREAS**, funding for the Supplemental AIP is embodied in the Supplemental Budget No. 2, FY 2018 and enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2018-018 dated December 5, 2018;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Angel M. Baniqued, Jr. and Generoso D. Tulagan, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Arth Bryan C. Celeste, duly seconded, it was –
