## **RESOLUTION NO. 79-2020**

**DECLARING ORDINANCE NO. 02-2019 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING THE SELLING OF CIGARETTES AND OTHER TOBACCO PRODUCTS TO PERSONS BELOW EIGHTEEN YEARS (18) OF AGE WITHIN THE TERRITORIAL JURISDICTION OF SAN JACINTO, PANGASINAN AND PROVIDING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Ordinance No. 02-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (iii) (3) (ii) of RA 7160;

**WHEREAS**, however, the Sangguniang Bayan shall take into consideration the observations of the Provincial Legal Officer stated in her opinion dated November 25, 2019;

**WHEREAS**, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of publication and posting pursuant to Sections 59 and 511 (a) of RA 7160;
