RESOLUTION NO. 791-2021

DECLARING ORDINANCE NO. 2020-26 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED, "AN ORDINANCE ESTABLISHING BURIAL SITES FOR DEATHS CAUSED BY COMMUNICABLE DISEASES IN ALL PUBLIC AND PRIVATE CEMETERIES/MEMORIAL PARKS IN THE CITY OF ALAMINOS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2020-06 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Section 458 (a) (i) (iv) (5) (xii);




