**APPROVING MUNICIPAL RESOLUTION NO. 118-2021 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 01, SERIES OF 2021 OF ANDA, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Anda, Pangasinan submitted its SB Resolution No.118-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Local Development Council of Anda, Pangasinan had identified items in their Supplemental Investment Program No. 01 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on July 15, 2021 by the Municipal Development Council through MDC Resolution No. 01, Series of 2021;

**WHEREAS**, the Supplemental Investment Program No. 1 covers fund augmentation for the Personal Services Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices and implementation of development projects and COVID-19 related programs of the municipality;

**WHEREAS**, said SIP has an investment requirement of P11, 118,977.02. Funding of which is supported by Supplemental Budget No. 1 in the amount of P2,197,092.86, which was approved and enacted by the Sangguniang Bayan on July 21, 2021 through Appropriation Ordinance No.01, Series of 2021, Quick Response Fund 2021 (P2, 250,000.00; unexpended LDRRMF in CYs 2016, 2017, 2019 & 2020 (P6,671,884.16);

**WHEREAS**, however, for the programs/projects/activities proposed to be funded from by the unexpended balance of 5% MDRRM Fund in previous years in the amount of P6,671.884,16, there is a need for the LGU to prepare a *Revised AIP* in accordance with Item 6.5 of MDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1, dated March 25, 2013;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Anda, Pangasinan;


