APPROVING MUNICIPAL RESOLUTION NO. 2021-51 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED, "TO ADOPT THE DETAILS OF THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 4 CY 2021, AS EMBODIED IN THE MDC RESOLUTION NO. 5, SERIES OF 2021 OF THE MUNICIPAL DEVELOPMENT COUNCIL OF BOLINAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its SB Resolution No. 2021-51 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Local Development Council of Bolinao, Pangasinan has formulated and endorsed the municipality's Supplemental Investment Program No. 4 through MDC Resolution No. 5, Series of 2021 dated August 6, 2021 to the Sangguniang Bayan for approval;

WHEREAS, the Supplemental Investment Program No. 4 of the municipality with an investment requirement amounting to Php142,610,000.00 covers the implementation of development projects and fund augmentation for the personal services, maintenance and other operating expenses and capital outlays of some offices in the municipal government;

WHEREAS, to support the implementation of the programs/projects embodied in the Supplemental Investment Program No. 4, the Sangguniang Bayan enacted Supplemental Budget No. 4 through Appropriation Ordinance No. 2021-04 dated August 12, 2021;
